Chancellor's Enrollment Cabinet Update Summer 2023 End of Term Report Executive Summary Data as of 12/03/2023

Context

- A. The **Credit Colleges'** Summer term started on June 5, 2023 and ended on August 12, 2023. There were **987 sections** scheduled (**City**: 236, **Mesa**: 457, **Miramar**: 294*).
- B. The **College of Continuing Education** Summer term started on June 12, 2023 and ended on August 26, 2023. There were **470 sections** scheduled for the Summer term.

Summary

Districtwide, there were 25,259 unique students attending the Summer 2023 term.

Credit Colleges - End of Term

- 1. FTES: The Credit Colleges reached 2,904 FTES (City: 703, Mesa: 1,353, Miramar: 848*).
- 2. The Progress to FTES Target (PTT) was 106% of the overall FTES target for the term. All the credit colleges surpassed their FTES Target (City: 100%, Mesa: 126%, Miramar: 111%).
- 3. **Productivity:** The Average Productivity for the Credit Colleges was **14.9** (**City**: 13.8, **Mesa**: 15.8, **Miramar**: 14.5).
- 4. **Headcount**: There were **15,098** unduplicated students enrolled across the Credit Colleges (**City**: 4,430, **Mesa**: 8,250, **Miramar**: 5,218*).
- 5. Enrollment: There were **25,113** enrollments across the Credit Colleges (**City**: 6,078, **Mesa**: 11,979, **Miramar**: 7,046*).

SDCCE - End of Term

- 6. FTES: SDCCE reached 1,413 FTES for the summer term.
- 7. **Progress to Target**: The Progress to Target for SDCCE at the end of the term was 87%.
- 8. **Productivity**: The Productivity at the end of term was **14.6**.
- 9. Headcount: There were 10,226 unduplicated students enrolled at the end of term at SDCCE.
- 10. Enrollment: There are 14,566 enrollments in the term.
