Anthropology for Transfer

Michelle Parsons advised the evaluators reviewed the six Mesa degrees and had recommended revisions. Libby Andersen requested a brief overview of the evaluators' revisions. Parsons advised the revisions were technical issues; unit calculation, correct insertion of "or" and "and" conditions. Andersen inquired if there was any discussion concerning the Business Administration for Transfer degree. Parsons advised the Business Administration degree was designed after the basic Transfer Model Curriculum (TMC) model.

Dan Igou advised Miramar's kinesiology degree is similar to City's and Mesa's, with variations among the physical education courses. Variable units listed on the TMC degrees discussed. Andersen advised she could provide documentation from other community colleges which reflects their approach to variable unit courses and TMC degrees. Lee recommended the information be distributed via email.
