#### ACTION ITEMS

# 1) Offering a recently activated course that is UCTCA approved at another college while waiting for UCTCA approval.

Evaluators and AOs recommend that if the course has not been approved for transferability, the college should not offer it. There is a potential negative effect on students who take the course without UCTCA status. Myra Harada will add the issue to the November 10<sup>th</sup> CIC agenda for review.

# 2) Student confusion between earning a degree and being ready to transfer. Liberal Arts, Option II degree requirements.

Evaluators and AO recommended adding the following statement "Earning an Associate degree does not imply completion of CSU G.E. or IGETC patterns. Check "Academic Requirements section of the catalog" pages 83 and 284 of City College catalog, pages 83 and 152 of Mesa College catalog and pages 111, 117 and 174 of Miramar College catalog.

Harada to add to the November 10<sup>th</sup> CIC agenda and invite Reginald Boyd to CIC, confirm with Vice President Bob Garber. Lim Kaiser may be alternate.

### 3) Difference between CSU (Golden 4) and CSU GE certified.

Admission to a CSU institution requires a grade of "C" or better in the Golden 4; to be CSU G.E. certified, a grade of "D" is sufficient.

Duane Short will come up with a draft statement clarifying the difference to students for the catalog and send it to Boyd for consideration. Once the statement has been finalized, Boyd will send to Articulation Officers and Evaluators. Harada to bring proposal to the November 10<sup>th</sup> CIC agenda for Senate review.

### 4) Upper Division Units.

Evaluators waive requirements with upper division courses if student petitions are approved.

#### **5)** CAN

Articulation Officers agreed to keep CAN designation in catalog until the 07-08 academic year.

#### 6) Issues with Course Numbering system and Baccalaureate-level Courses.

Discussion regarding the use of 100 - 299 course numbers to indicate baccalaureate-level course outlines. Separate CSU transferability from private universities. Juliette Parker to bring this issue to the December  $8^{th}$  CIC meeting. Harada to add to CIC agenda for Senate review.

#### 11) Concern regarding inclusion of Prep for Major in the catalog.

Current prep for the major in the catalog is one year behind the four year catalog. Short to bring the issue to CIC on December 8<sup>th</sup>. Harada to add to CIC agenda for Senate review.

### 12) DAC meeting with Evaluators.
