Old Business

1. GEOG 104 update:

Content needs to be added to the course to prevent losing articulation with SDSU. Duane created a proposal in CurricUNET and designated Elizabeth Castaneda as a co-contributor with access to all proposal pages.

2. UCTCA, IGETC and Catalog listing discrepancies:

Michelle will e-mail the discrepancies chart to the Articulation Officers and changes will be included in the second submission of the UCTCA.

3. MOU Hiroshima College

Juliette talked about establishing MOUs with non-regional accredited institutions such as Hiroshima College. Juliette will present the information at a CIAC meeting.

4. SDSU Accounting courses:

SDSU Accounting Department made a decision to terminate course-to-course articulation agreements and allow only LDTP articulation, colleges that do not comply with this will lose articulation of those courses effective fall 2009. Articulation Officers agreed to bring up this issue at one of the upcoming regional Articulation Officer meetings.

5. New SDSU meeting request regarding graphic arts articulation:

The Mesa College Art Department is still interested in pursuing a meeting with SDSU regarding de-articulation of graphic arts courses. The department is planning on pursuing this via administration channels if necessary.

New Business

6. Articulation for Online Courses:

Juliette found out that USD does not accept online courses; a note can be found on their website, Juliette will e-mail page to Shelly and Articulation Officers. A Mesa student transfer to USD and was told that two courses will not transfer because these

courses were taken online. Articulation Officers suggested finding out which courses were no accepted and if these courses are on the articulation agreement; Juliette will research this and will talk to student.

7. Embry-Riddle articulation:

Embry Riddle started a new program attached to the agreement with Miramar for students to dually enroll at their school and at the college. Embry Riddle will be teaching a class at Miramar through a facilities agreement. Miramar will draft an MOU with Embry Riddle.

8. Ashford University articulation proposal:

Henry Ingle sent information to the Articulation Officers about an articulation proposal with Ashford University and requested feedback. Articulation Officers will process the proposal from Ashford as a routine request for new articulation

9. SWC Dental Hygiene articulation grid:

Mesa College will reply to Southwestern on behalf of all three colleges.

10. C-ID pilot project:

Juliette provided the information about the course identification system as an FYI.

11. Consistency: Foreign Language Prerequisites:

First semester foreign language courses need to include in their description the following statement: "Equivalent to two years of high school study". Shelly recommended reminding faculty to include the statement when proposals for these courses are made.

12. CLEP, IB, DANTES:

Libby requested an update of the courses that were pending approval; Articulation Officers provided the following information:

Studio Art, no agreement was reached.

Environmental Science approved for BIOL 120, area B, 4 or 5 required score, no credit for CSUGE and credit for IGETC, Area 5.

Human Geography, approved for GEOG 102, area D, 3, 4 or 5 required score, no credit for CSUGE and credit for IGETC, Area 4.

13. Henry Ingle announcement:

Shelly announced that Henry Ingle, Vice Chancellor of ISPT has accepted a position with a local university.
