- 2. University of Redlands MOU Renewal: Mara Palma-Sanft Shelly sent the MOU changes the Articulation Officers requested to the University of Redlands representative. Once the MOU is ready, the Articulation Officers will take the MOU back to their campus for review.
- 3. Physics 125, 195, 196, 197: Mara Palma-Sanft UCSD's articulation officer contacted Mara about the UCTCA limitation posted on ASSIST for Physics 125, 195, 196 and 197:

"* 125, 126, and/or 180A, 180B, 181A, 181B and/or 195, 196, 197 combined: maximum credit, one series."

The articulation officer is concerned the language may be confusing for students and wants the limitation to be revised so it's clear the UC will only award credit for one series. Articulation Officers will contact the UC and revise the limitation.

4. Statway articulation: Elizabeth Norvell

Elizabeth had a conference call with Articulation Officers from colleges that offer Statway courses and part of the discussion was the idea of doing group articulation between colleges from northern and southern California. She will follow up with Karen Klipple at City College.

5. Point Loma MOU: Shelly Hess

Point Loma Nazarene University has joined other colleges (Southwestern, Grossmont and MiraCosta College) to offer adult baccalaureate degree programs separate from their oncampus programs and the classes will be offered at the community college campus. City is interested in offering a Nursing degree, Miramar is working on Criminal Justice and Child Development and Mesa is looking at Management and Relationship development. Shelly is working on the MOU language and will keep Articulation Officers updated.

6. C-ID Resolution for ASCCC: Juliette Parker

Juliette informed the Articulation Officers the C-ID resolution articulation officers presented to the State Academic Senate Area D meeting was not approved.

7. UC admission changes Fall 2016: Shelly Hess

Shelly explained students have to complete the major preparation course work before they can be admitted to a UC campus effective fall 2016. Articulation Officers discussed the issue and suggested creating a "courses active but not offered" report for UCSD. Shelly will follow up.
