### What do we currently do & what do we currently know?

  - The LGBTQIA+ Education & Advocacy Program provides school site resources and district support to meet the needs of LGBTQIA+ students and their families. The program provides professional development opportunities; educator, student, and family resources; and inclusive curriculum.       - Between 4% and 8% of enrolled students reported belonging to the LGBTQ community (City/ECC: 8%, Mesa: 6% and Miramar: 4%).
      - Less than 1% of newly enrolled students reported that their gender identity was non-binary. (This field was added in October 2019).
      - A significant proportion of students (36%) did not select a response or declined to state when asked about transgender.
