Note 5. 'Online' includes Fully Online and Partially Online courses. Fully Online courses have no on-campus instruction or exams. Partially Online courses have at least one class meeting or exam on campus and more than 50% of instruction is delivered online. 'On Campus' includes On-Campus courses and Hybrid courses. Hybrid courses have more than 50% of the instruction on campus while less than 50% is online. Distance Education courses at Continuing Education either have onsite registration, onsite orientation, or a companion course that meets onsite.
