College Productivity Report – Fall 2012 As of Final Census

Purpose

This report has been prepared in order to provide four productivity indicators for City/ECC, Mesa, and Miramar Colleges for the last four fall terms including Fall 2012.

FTES/FTEF Ratio

FTES and FTEF data are from end of term. As a point of reference, for a Census Week class, an FTES/FTEF ratio of 15 would equate to a class size of approximately 30 students.

The FTES/FTEF ratio for City College/ECC increased in Fall 2012 compared to the previous term. For Fall 2012, the average class size for each college was as follows: City/ECC 33.7, Mesa 34.6, Miramar 35.6, and District 34.5. The District benchmark (based on the average of the reported four fall terms) is 17.2.

Note 1. Non-residents, tutoring, apprenticeship, in-service, non-state supported, and cancelled classes were excluded.

Yields

Data were used from end of term to calculate the yields. Yields are calculated by taking the total amount of FTES and dividing by the total number of related sections. For example, if the total FTES were 24.83 and there were 5 related sections, the resulting yield would be 4.97.

The three colleges showed improvement in a few accounting methods in 2012 compared to the previous term (see Table 2). The City College/ECC yields increased in all areas in 2012 except for Positive Attendance compared to 2011. At Mesa College the Positive Attendance, and Independent Study Census Week yields for Fall 2012 increased compared to Fall 2011. Miramar College showed improvement in all yields except for Independent Study Census Week and Work Experience Census Day in 2012 compared to 2011.

Load

Data were used from end of term to calculate the loads. Load is the ratio of Weekly Student Contact Hours (WSCH) to Full-time Equivalent Faculty (WSCH/FTEF) and is a measure of productivity. The statewide benchmark for load is 525.

In Fall 2012, the load values for City College/ECC increased compared to the previous term.

Load: The ratio of Weekly Student Contact Hours (WSCH) to Fulltime Equivalent Faculty (FTEF). The statewide Load benchmark for a 17.5 week semester is 525. The Load benchmark for SDCCD's 16.5 week semester is 557.

Note 1. Sections with zero WSCH, positive attendance, in-service, and cancelled sections are excluded.

Fill Rate

The capacity and enrollment data, for all accounting methods, were used to analyze fill rates. Data were as of end of term and were used for all four terms. Enrollment as of census was divided by the course capacity to calculate fill rates. As a point of reference, if there are 25 students in a class with a cap of 40, the fill rate would be 0.63.

The overall fill rates for Fall 2012 increased compared to the previous fall term. The overall fill rates for City College/ECC in Fall 2012 increased compared to Fall 2011.
