College Productivity Report - Fall 2013

As of First Census

Purpose

This report has been prepared in order to provide four productivity indicators for City/ECC, Mesa, and Miramar Colleges for the last four fall terms including Fall 2013.

FTES/FTEF Ratio

FTES and FTEF data are from First Census and only include the Census Week accounting method. As a point of reference, for a Census Week class, an FTES/FTEF ratio of 15 would equate to a class size of approximately 30 students.

The FTES/FTEF ratio for all three colleges decreased in Fall 2013 compared to the previous term. For Fall 2013, the average class size for each college was as follows: City/ECC 34.8, Mesa 34.1, Miramar 35.0, and District 34.5. The District benchmark (based on the average of the reported four fall terms) is 17.6.

Yields

Data were used from First Census to calculate the yields. Yields are calculated by taking the total amount of FTES and dividing by the total number of related sections. For example, if the total FTES were 24.83 and there were 5 related sections, the resulting yield would be 4.97.

The City College/ECC yields for Work Experience Census Week and Independent Study Census Day sections increased in 2013 compared to 2012. Miramar College showed improvement in Census Day yields in 2013 compared to 2012.

Load

Data were used from First Census to calculate the loads. Load is the ratio of Weekly Student Contact Hours (WSCH) to Full-time Equivalent Faculty (WSCH/FTEF) and is a measure of productivity. The statewide benchmark for load is 525.

In Fall 2013, the load values for each college decreased compared to the previous term.

Load: The ratio of Weekly Student Contact Hours (WSCH) to Full-time Equivalent Faculty (FTEF). The statewide Load benchmark for a 17.5 week semester is 525. The Load benchmark for SDCCD's 16.5 week semester is 557.

Note 1. Sections with zero WSCH, positive attendance, in-service, and cancelled sections are excluded.

Fill Rate

The enrollment and capacity data, for all accounting methods, were used to analyze fill rates. Data were as of First Census and were used for all four terms. Enrollment as of census was divided by the course capacity to calculate fill rates. As a point of reference, if there are 25 students in a class with a cap of 40, the fill rate would be 0.63.

The overall fill rates for each college in Fall 2013 decreased compared to the previous fall term.
