## STUDENT SUCCESS SCORECA

The 2015 Student Success Scorecard will be posted on the college, **Continuing Education** and District websites beginning in April. The data available in this scorecard tell how well colleges are doing in remedial instruction, job training programs, retention of students and graduation and completion rates.

## **Associate Degrees for Transfer Update**



Over the past three years the Associate Degree for Transfer program has ramped up across the state. Currently there are 25 transfer degree programs that are approved statewide, and 17 **AA-T/AS-T** new programs in the District (City-17, Mesa-16, Miramar-15).

Students who earn this transfer degree are guaranteed admission to a California State University (CSU), although it may not be their CSU of "choice." Additionally, students at a CSU who earn an Associate Degree for Transfer are guaranteed to earn a bachelor's degree after completing 120 units.

The District evaluators have been busy certifying 909 AA-T and AS-T degrees for early verification through the CSU E-Verify system. This is almost a 100% increase from the previous year (482). As you can see from the chart, more students are becoming aware of the benefits of earning an Associate Degree for Transfer.

## Title IX & Campus SaVE Act Update

District Student Services is launching a new Title IX & Campus SaVE Act webpage at <a href="http://">http://</a> www.sdccd.edu/titleix/. This page provides students with important resources, policies and instructions on how to prevent, and report incidents of sexual violence to the appropriate Title IX coordinator on each campus.

## New Board of Governor's Fee Waiver Eligibility Rules

Effective Fall 2016, in accordance with recent changes to the California Education Code and Title 5, students who are disqualified due to GPA or lack of progress will lose their Board of Governors (BOG) fee waiver. The District has begun to notify students if they are at risk of losing their BOG fee waiver eligibility so they may take appropriate steps to remain in good academic standing. Students will have the option to appeal the loss of BOG fee waiver eligibility if they have extenuating circumstances with documentation.

Implementation details are being worked through with Financial Aid officers. More information to follow.

## Nonresident High School Students—Tuition Exemption

In 2014, the state legislature enacted changes to the California Education Code permitting community college districts to exempt special part-time high school students from paying nonresident tuition when concurrently enrolled in college courses. The District has been working to put procedures in place to implement the change. While this exemption waives the nonresident tuition, it does not qualify these students as California residents.
